Conditions – Deactivation/ Reactivation of i-Pass

- The applied permanent i-Pass will be deactivated if the number of trips is less than 6 in the preceding 3 months upon the issuance of i-Pass.
- The suspended i-Pass can be reserved for re-activation provided that the number of single i-pass trip records is not less than 6 in the past 3 consecutive months upon the application.
- The final decision of reactivation of the suspended i-Pass is subject to AAT's approval.

細則 - 暫停使用/ 重新啓動智泊咭

- 車輛須在發出智泊咭後有慣常使用智泊咭之記錄(即三個月不少於六次進場記錄)，否則其智泊咭將被暫停使用；
- 使用者可申請重新啓動智泊咭，其車輛必須在三個月內持有不少於六次單次智泊咭進場進記錄；
- 有關智泊咭重新啓動事宜，AAT 保留最終決定權。
